

The interim contracts may be offered to eligible current Deputy Registrars, to unsuccessful proposers, or to other persons, as appropriate.

Before we sign your final contract for appointment as a Deputy Registrar we require that you cure any deficiencies contained in your proposal, meet any contingencies we have prescribed, and come into compliance with all applicable provisions of the Ohio Revised Code, the Ohio Administrative Code, and the Deputy Registrar contract. A BMV Field Representative will contact you regarding the arrangements necessary for you to come into full compliance and your schedule to begin operations. When everything is in order, Registrar Williams will sign the contract, finalizing your appointment.
